### 4. First-Aid Measures

**General advice:**

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. ### 6. Accidental release measures

**Personal precautions:**

Take appropriate protective measures. Clear area. Extinguish sources of ignition nearby and downwind. Ensure adequate ventilation. Wear suitable personal protective clothing and equipment.

**Environmental precautions:**
